#### Introduction

In determining what services to provide to its community, the Council takes account of:

- Legislative requirements that require the Council to provide certain services;
- Consultation with the community;
- The Council's strategic management plan;
- The need for long-term financial sustainability; and
- The resourcing and income that may be associated with desired services.

These are services that Southern Mallee District Council will deliver at levels which are affordable having regard to Council's financial sustainability targets.

For each of these Statutory required services and primary discretionary services Council may develop a separate service level policy, describing the level of service that the Council intends to provide.

Council will develop a separate service level policy, describing the level of service that the Council intends to provide for Customer service, Waste and recycling services, Open space services and Roads services.

- Maintenance of secondary recreations reserves in Parilla and Geranium
- Maintenance of commercial centre parks and gardens areas in Lameroo and Pinnaroo
- Maintenance of road side areas in Lameroo, Pinnaroo, Parilla and Geranium

### Waste management

- Collection of waste and recyclables from Lameroo, Pinnaroo, Parilla, Geranium and Parrakie
- Landfill facility at Lameroo
- Transfer stations at Lameroo, Pinnaroo and Geranium

# What will Council provide?

For each of the above services, the corresponding service level policy will clearly express:

- the level of service the community can expect from the service;
- Council's role and responsibility in the delivery of the service;
- Means of delivery of the service; and
- How operating revenue will be raised to offset operating expenses associated with service provision.

The service levels expressed in each of the service level policies will:

- be based on community consultation
- recognise the importance of Council's long term financial sustainability

- take into account the limited resources available to Council
- provide the direction for other relevant plans developed by Council
- be subject to review as circumstances change.

The respective Service Level Policies will not include the annual cost of providing the service at the nominated level, because these costs will vary over time. However, the Council will strive to maintain the designated levels of service in the most cost-effective manner.

In compiling its annual business plan, and determining the resources necessary for each financial year, the Council will refer to its Service Level Policies.

The Council will keep under review the cost of providing each service, to the levels specified in its Service Level Policies, and will take into account the financial implications for Council's other services, and the impact on Council's operating surplus/deficit.

Council's performance in meeting the specified levels of service will be included in its Annual Report.

## Secondary discretionary services

These are services that the Council will deliver, at levels which ensure the long term financial sustainability of Council, but without a designated service level policy for the service.

## Places of public assembly

- Primary community halls in Lameroo and Pinnaroo
- Local community hall in Parilla

## **Aerodrome facility**

An aerodrome in Pinnaroo to service Southern Mallee

## **Community amenities**

- Public toilets in Lameroo, Pinnaroo, Parilla and Geranium
- Street cleaning in Lameroo, Pinnaroo, Parilla, Geranium and Parrakie

# Cemeteries

Provision for burial and memorialising cremated remains in public cemeteries at Lameroo, Pinnaroo and Parrakie

## **Traffic management**

Enforcing parking requirements within the commercial area of Lameroo and Pinnaro

- Provision of parking in the commercial area of Lameroo and Pinnaroo
- Road closures for events

# **Public safety**

- Monitoring of insanitary conditions
- Control of public nuisances
- Street lighting

# **Swimming pools facilities**

Providing swimming pools at Lameroo and Pinnaroo

Council is committed to delivering each of these services at levels that are affordable and consistent with the achievement of Council's long-term financial sustainability targets, taking into account both the needs and preferences of its community for the various services and Council's financial constraints.

### **Policy review**

The effectiveness of this policy will be reviewed every three years or as necessary.
