### 13.3 Late Confidential Item - Extension of Mobile Garbage/Recycling Collection Service

#### Question on Notice at June 2016 Ordinary Council Meeting

Could the administration consider;

1. The implications for extending the Council normal garbage collection services to land in the Rural Living Zone.

#### Answer

By extending the collection service the time to collect the additional properties would be in the vicinity of 5 minutes for each of the garbage collection runs covering Thursday and Friday. [There are no Rural Living Zones at Geranium, Parilla and Parrakie]

2. The cost of providing such a service per dwelling.

#### Answer

The fee to provide the service will be in line with the current Council Kerbside garbage collection levy of \$175.00 per annum

3. The mechanism, if any for the land owners to contribute to the cost of having their rubbish collected.

#### Answer

If the landowner receives a Kerbside garbage collection then they pay the levy set by Council, currently \$175.00 per annum

4. Whether imposing such a cost is fair based on the rates they presently pay.

Rural living zone landowners pay the same rates as township who pay the Council's current Kerbside garbage collection levy of \$175.00 per annum

5. Whether the service could possibly start July 1<sup>st</sup>.

#### Answer

As per Council's Mobile Garbage Collection Service Policy for township and rural living properties the service is provided and made available as long as they are on the rubbish collection route. The current policy map route shown in the Policy's diagram only covers the Mallee Highway and is not defined in the townships. There are at the moment currently properties that are rural living zoned that get their rubbish collected and are on the current kerbside collection route within the townships.

Council has the capacity as highlighted in Q1 response to change the route to accommodate the other residents in question if they want the service provide without changing Council's currently Mobile Garbage Collection Policy.

If Council decide to go this way then a letter will be written to those households effected advising of Council's decision and for them to indicate to Council if they intend to use the service at the current Council Garbage levy fee of \$175.00 per annum

#### Recommendation
