Executive Summary

The purpose of this report is to enable Council to determine the awarding of the lump sum contract for the development of decking at the childcare centres in Pinnaroo and Lameroo. There is a detailed quotation evaluation report attached to this report.

Council has received a detailed Southern Mallee Community Infrastructure Project (SMCIP) report to this council meeting. Expenditure on the childcare centre developments has exceeded the original project budget.

The development of a significant area of decking to the rear of each childcare centre is integral to the childcare centres. It is necessary for functionality of the centres. It was always outside of the contract with Ausco; the firm constructing the childcare centre buildings.

The preferred contractor for the development of the decking at the childcare centres has provided one quotation for work which would be replicated at each side. The total quotation amount is \$83,852.

This additional project cost will be presented to Council again in October when Council considers Budget Review 1 for the 2019/20 financial year.

The preferred contractor is Scott Meneghetti Carpentry for a lump sum contract price of \$83,852.00 (excluding GST).

Background

Council has detailed designs for the Pinnaroo and Lameroo childcare centres. Those designs were then used to support the request for quotation process. Council received quotations from two firms.

Context

Council at its meeting on 21 November 2018 endorsed the development of the Pinnaroo and Lameroo childcare developments and the Pinnaroo and Lameroo swimming pool upgrades as the projects to be funded by the Commonwealths Government's Drought Communities Programme.

Council has already completed all onsite preparatory works, the offsite construction of the childcare centres has been completed by Ausco and onsite installation has commenced.

Policy and statutory implications

Council has undertaken the request for quotation process and evaluation in accordance with its Procurement policy.

Issues

Council has been progressing the childcare centre development since the start of this year and has been focused on commissioning the construction of the facilities, obtaining all necessary approvals and preparing the site. The onsite building installation is the next major phase of development with the buildings being transported to site, connections to all utility services occurring and works such as decking, ramps, fencing and landscaping being undertaken.

An earlier report to this meeting provides a detailed overall project update, including a budget update.

The childcare service provided by Council is highly valued and the development of the two childcare centres will have significant social and economic benefits to the whole community for many years to come.

Alternate options

Council has no other obvious alternative to awarding the contract for this work. If this work is not undertaken the childcare centres could not be completed and would not be able to gain necessary Commonwealth and State Government approvals and could not operate.

Council can utilise accumulated savings to fund the increase in the total project budget for the overall childcare projects, including the installation of the decking. Alternatively Council could look at part, or wholly funding, an increase in the total project budget for the childcare centres by reallocation of funds from other projects in the 2019/20 annual business plan and budget. This is not recommended and should include community consultation if it is the preferred option.

Financial implications

The development of the two decking areas at each of the two new childcare centres will cost \$83,852. This amount is outside of Council's previously approved budget. If Council does not approve an increase to the overall budget amount then this part of the project cannot be undertaken and the childcare centres cannot be completed.

Council has accumulated savings. These projects are considered high value projects, in terms of their support from the community, and social and economic value to the community. The expenditure of accumulated savings on projects such as this can be justified.

Work Health and Safety and Risk implications

This report raises no new work health and safety issues. A decision not to deliver the decking projects, and thus not enable the completion of the childcare centre developments would be a very significant risk to Council's reputation. The projects have significant levels of community support. There would also be risks related to Commonwealth funding if Council decided not to complete the projects.

Consultation

There is a small project steering committee for the delivery of the two childcare centres with one elected member, Lameroo Regional Community School and Pinnaroo Primary School representation and relevant project staff. The community has been kept up to date on this project through regular project newsletters.

Council is in regular contact with relevant Commonwealth and State Government departments about this project.

Selection Criteria 1 - Cost to Council

Direct

The tender/quotation price submitted for the provision of goods, services or works.

All costs associated with the management, including risk management and contract management, of the contract supervision shall be applied consistently to each tender submission. For example contract supervision, asset resource utilisation and risk management. Should significant differences in requirement of Council be apparent the comparative indirect costs borne by Council must form part of the evaluation.

Handbuilt Homes Riverland's multiple options and less detail made their submission confusing.
