**Background**

This is a brief report to inform elected members of the current status of the contaminated land remediation works.

**Context**

At the June 2020 meeting council approved the expenditure of funds to remediate the northwest quadrant of the land between Railway Terrace North and South that adjoins Gordon Terrace in Pinnaroo.

**Issues**

These works were scheduled to commence in July however due to recent wet weather events and significant weed growth in this area it means that it would have been unlikely for the contractor to adequately ensure a positive result.

Subsequently the area has been sprayed to foster a significant reduction in vegetable matter so that the contractor can ensure that remediation works are successful. At this stage the vegetable matter is still significant and council staff continue to monitor the area. Remediation activities will commence once councils contractor is satisfied that enough vegetable matter has died off to successfully remediate the site.
