As the Council is aware the Chief Executive Officer residence situated at 18 Hensley Street Pinnaroo has been vacant for a number of months and the Council has suggested this residence be rented. There has obviously been word get out that the house is becoming available to rent as there has been approximately 4 enquiries regarding this. This is despite no formal resolution being made or investigation into conditions around leasing the property.

As the Council are aware this forms a part of the Chief Executive Officer's salary package and forms part of the employment contract signed by the Council and the Chief Executive Officer. As such the Chief Executive Officer proposes to renegotiate this part of her salary package.

As per the employment contract schedule 1, the non-cash value placed on the Chief Executive Officer residence is \$8,320. Based on rental values and limited availability it is suggested that the rental value that may be achieved for the letting of the Chief Executive Officer residence would be anywhere from \$200 to \$250 per week. An annual figure of between \$10,400 and \$13,000.

The proposal for renegotiation put forward is as follows;

- 1. For an additional 2 weeks leave per year. Current dollar value \$4,731
- 2. For an additional 2% superannuation. Current dollar value \$2,460 Total current dollar value of the proposal is \$7,191

As these figures are adjustable by way of wage increase it is noted that any increases to the Chief Executive Officer wage is set at the CPI rate for Adelaide. As such the rental value should also increase annually at a rental review by the same methodology.

The annual difference to Council is \$3,209 to \$5,809 per annum based on the suggested rent values. This may be slightly higher if a better rental amount can be achieved.

Recommendation

That the Council do / do not endorse the variation to the Chief Executive Officer contract as follows;

- 1. remove the rental subsidy and amount of \$8,320 and use of the property situated at 18 Hensley Street Pinnaroo;
- 2. Include an additional 2 weeks leave per annum; and
- 3. Include an additional 2% superannuation on top of the Compulsory Guarantee Superannuation percentage set by the Federal Government.
