Executive Summary

This report enables Council to award the tender for renewal works at the Lameroo Memorial Hall and Pinnaroo Institute.

Council allocated funding in the 2020/21 budget for the design and implementation of renewal works to both the Lameroo Memorial Hall and the Pinnaroo Institute.

Council has undertaken three formal tender processes in an effort to attract a tender submission for this project. A single tender for delivery of these works has now been received and assessed.

The single tender was received from Scott Meneghetti Carpentry & Building. The tender proposal provides for a total project cost of \$166,826.00. The detailed tender submission documents for the two sites are attached.

RECOMMENDATION

That Council awards the contract for Lameroo Memorial Hall and Pinnaroo Institute Renewal Works to Scott Meneghetti Carpentry & Building for a contract price of \$166,826.00 (ex GST).

Background

Council's Strategic Plan, Goal 3, identifies that Council will deliver the services and facilities to meet community needs. One way that council achieves this is by investing in its public buildings.

Lameroo Memorial Hall and Pinnaroo Institute are Council's primary community meeting spaces and both require investment to renew them to an acceptable standard.

The majority of the works proposed as part of this renewal project were identified as areas of concern in the property assessment reported written by Council's building inspector Terry Bush.

Context

Council has experienced a protracted challenge in attracting a tenderer for these works.

Council advertised for tenders for the total Lameroo Memorial Hall and Pinnaroo Institute renewal works via the LGA Procurement website to a panel of pre-qualified companies and also sent the tender specifications to other identified contractors. The initial tender opened to an identified group of building construction companies on 1 February 2021 and closed 22 February 2021. There were no tenders submitted nor any site visits to understand the site works.

The second tender period opened 15 March 2021 and closed 7 April 2021. This was placed on the LGA procurement site and sent to identified building construction companies directly. Again no tenders were submitted.

In late April, council staff directly contacted contractors over several days to determine their level of interest in the project. Only Scott Meneghetti Carpentry & Building and Tyson Beck General Building responded positively. Both indicated that they were interested but that the tender timeframe for delivery was too short for them to deliver the projects on time and that they were currently heavily engaged with other projects.

Other general building contractors from Southern Mallee, Bordertown, Murray Bridge & the Riverland were all directly contacted with varying responses such as currently too busy, not interested / too far away and can't secure accommodation. The third tender process was then extended to Scott Meneghetti Carpentry & Building and Tyson Beck General Building with a closing date and time of 5pm 26 May 2021.

At the close of the tender a single tender was received from Scott Meneghetti Carpentry & Building.

Policy and statutory implications

Council has a procurement policy and the tender process has been undertaken in accordance with the policy.

All Council purchases must be carried out in compliance with the Local Government Act 1999 (the Act). Section 49 (a1) of the Act requires Council to develop and maintain procurement policies, practices and procedures directed towards:

- Obtaining value in the expenditure of public money, and
- Providing for ethical and fair treatment of participants, and
- Ensuring probity, accountability and transparency in the procurement process.

Council is not obliged to accept the lowest tender or any tender.

Issues

The tender from Scott Meneghetti Carpentry & Building was assessed to determine if it met the criteria in the tender documents. Tender prices provided by Scott Meneghetti Carpentry & Building are all GST exclusive.

The tender received from Scott Meneghetti Carpentry & Building provides a cost for works at the Lameroo Memorial Hall of \$64,556.00. The cost of works at the Pinnaroo Institute is \$102,270.00. Providing a total project cost of \$166,826.00. The tender is considered to be fair and reasonable and meets the tender specifications.

The detailed budget source for these works and submitted tender prices are as follows:

The Lameroo renewal works require access to a larger contingency budget as there are several unknown factors including a potentially large amount of asbestos removal (subject to testing), the unknown condition of the floor boards in the dressing room once the carpets are stripped back and the potential for salt damp treatment to be required. Council reporting will be necessary to gain approval for any substantial change in the scope for renewal works at the Lameroo Memorial Hall. There is some additional budget available in the Lameroo Memorial Hall renewal budget item and also the Implementation of Council Building Assessment report budget item.

The Pinnaroo Institutes asbestos has been previously identified in other works and is of a small enough quantity that Scott Meneghetti Carpentry & Building are authorised to remove it. The Pinnaroo Institute include disability access works to the front of the building and a concept plan of these works is attached.

Given the difficulties associated with attracting a contractor and the timing of this awarding of contract late in the financial year, these works will now occur in the first quarter of 2021/22 rather than this financial year.

Alternate options

Council could run a new tender process. This is not recommended as it would delay the project further and because of the issues council has had in getting tenders for this work remain.

Financial implications

The contract for the subject works are within budget even if some additional works are required.

Work Health and Safety and Risk implications

There are no risk implications associated with this matter, potential asbestos containing material has already been identified on both sites and will be dealt with accordingly.

Consultation

Council included this capital allocation within the Annual Business Plan and Budget which was the subject of community consultation.

 Quote includes, Removal of existing splash back tile, chipping out and scraping back any bubbled or loose paintwork/ plaster, re render/plaster where required and install 600x300 white gloss tiles vertically 11 meters long and .6m high.

- -Install compliant emergency exit doors for escape from the main hall.


