Sa Tractors have offered 2 skid steers for Council to consider with the SR200 having more horse power and slightly bigger. Both machines are presented well, enclosed cabs with air-conditioning. It has all the features that Council need and either would be more than adequate to meet Councils needs

Bobcat S590

SA Lift and Loader offered the one machine for Council to look at. It had enclosed cab with air conditioning and all other features that council need. The layout of the instruments were a bit confusing and would take quite a while to get used to plus the operator felt uncomfortable in the seat

Council's Plant Operator

Council's plant operator was impressed with both the Case and Caterpillar that were offered to trial.

Case SR200 had a comfortable seat, less grease points and the feel was good. The ability to vary the hydraulic flow to allow all kinds of operators to use was also good. 3yr 3000Hr warranty. The operator recommended this as the pick of the machines

Cat 236D had a comfortable seat, safety bar was unique and good and had good manual throttle. The ability to vary the hydraulic flow to allow all kinds of operators to use was good and a 3yr 3000Hr warranty. The operator thought this was also a good machine and was worthy of also being considered

The layout of the controls and the seat in the Bobcat were uncomfortable and this was therefore ruled out by the operator

Council's Caterpillar 226 Skid steer Loader with attachments was also advertised to be sold separately to gather whether there was any interest locally. Council received 1 response for \$18,000 +GST however this was received after the closing date of the 3 April 2018 5pm
