Rubble Crushing Tender 2018 [3Yr + 1 + 1]

The Southern Mallee District Council called for Tenders via a selective tender process incorporating 3 companies for the provision of crushing and estimated 40,000m³ per year for 3 years in Council pits throughout the Southern Mallee District

The Tender opened on 7 March 2018 and closed 3 April 2018

Tenders were received via email to matthew.sherman@southernmallee.sa.gov.au

Of the 3 Companies that were part of the tender process 2 replied and 1 did not. An evaluation was undertaken on all tenders and the following information is supplied If Council looks at the price per 40,000 Tonne crushed per year and 3 year total it will be as follows

Southern Contracting Group	\$3.63 Tonne [shift cost included]	\$145,200	\$435,600

At present Southern Contracting Group has crushed rubble for Council for the past 3 years and has done an exception job in not only crushing but working with Council to get the best outcome

Recommendation

That the Council again engage Southern Contracting Group for the next 3 year period to crush rubble. Also before the end of the 3rd year of the contract finishing the Council enter into discussions with Southern Contracting Group to provide the service for an additional year
